Instructions for the Colorado Individualized Health Plan & Addendums

The Individualized Health Plan (IHP): Diabetes in School Setting and Addendums should be used in conjunction with the *Standards of Care for Diabetes Management in the School Setting – Colorado* and the individual student's orders from their Health Care Provider.

Purpose:

- 1. To provide clear and concise directions for individualized diabetes management.
- 2. Facilitate a safe process for the delegation of nursing care and support quality assurance of school health services.
- 3. As documentation for Special Education Nursing Services for Individualized Education Plan (IEP) and Section 504 plans.

Components of Individualized Health Plan: (choose appropriate plan for student/situation)

- 1. **Individualized Health Plan: Diabetes in School Setting**: This IHP should be used for all students in which school nurse/delegated Unlicensed Assistive Personnel (UAP) will provide diabetes management or assistance.
- 2. **Emergency Action Plan**: Glucose Monitoring & Treatment is used for all students with diabetes in managing hypoglycemia and hyperglycemia, and is also included in IHP.
- 3. **Insulin Injection & Medication Administration Addendum:** to be used as appropriate when school nurse/delegated UAPs will provide Insulin or medication management and/or assistance.
- 4. **Insulin Pump Addendum:** to be used as appropriate when school nurse/delegated UAPs will provide Insulin Pump management and/or assistance.
- 5. **Continuous Glucose Monitor (CGM) Addendum:** to be used as appropriate when school nurse/delegated UAPs will CGM management and/or assistance.
- 6. **Diabetes Management Supplies Addendum:** to be used as needed for provision of diabetes management supplies.

Additional Care Plans to be used as appropriate and needed include:

- 1. **Student Plan Self-Management:** For Classroom Teachers & School Staff –student self manages diabetes care.
- 2. **Transportation Care Plan**: For bus drivers, bus aides
- 3. **Hypoglycemia/Hyperglycemia Flowchart:** For Classroom Teachers & School staff use in conjunction with IHP, Classroom Daily Care Plan, Student Plan Independent Management.
- 4. **Daily Health Check Addendum for Diabetes Care:** May be used for Daycare providers when student's with diabetes are dropped off.

Process:

1. School nurse completes *School Nurse Intake Form* and/or assessment.

- 2. School nurse completes appropriate IHP, Addendums and care plans as needed for the student/situation.
- 3. The school nurse should complete these forms in conjunction with the parent, based on the Health Care Provider's orders and the *Standards of Care for Diabetes Management in the School Setting Colorado.*
- 4. The school nurse should also consult with school staff and teachers regarding snack/PE times, etc.
- 5. When the school nurse has completed the IHP, Addendums, care plans, the school nurse and parent should sign and date forms.
- 6. It is *not* necessary for the Health Care Provider to sign the IHP, Addendums, care plans as the IHP is based on current Health Care Provider Orders.
- 7. The IHPs and Addendums should be updated as needed based on changes to care.
- 8. The IHP and Addendums must be updated annually.
- 9. The school nurse should use the IHP, Addendums, and care plans for trainings and delegations.
- 10. The school nurse will notify parent/guardian(s) of staff trained and delegated.
- 11. The school nurse should disseminate the IHP, Addendums, and care plans to teachers & school staff as appropriate.
- 12. File in appropriate student health record at the end of the year or upon student withdrawal as directed by state, district or school process.
